WE ARE CURRENTLY WORKING ON THE DEVELOPMENT OF A BREAST FLUID TEST TO IDENTIFY WOMEN AT HIGH RISK FOR BREAST CANCER, AS WELL AS RESEARCHING IF THERE ARE BACTERIA IN THE BREAST DUCTS AND HOW IT CAN HAVE AN EFFECT ON DEVELOPING BREAST CANCER. THE FOUNDATION IS ALSO IN THE PROCESS OF BUILDING A MODEL FOR LOOKING INTO ENVIRONMENTAL FACTORS AND BREAST CANCER RISK. OUR GOAL IS TO END BREAST CANCER, AND IN ORDER TO DO THAT, WE HAVE TO BE FAST, FLEXIBLE, AND PROJECT-BASED WITH OUR RESEARCH APPROACH. WE IDENTIFY NEEDS AND DETERMINE HOW THESE NEEDS CAN BE QUICKLY MET, NOT BY EMULATING EXISTING NONPROFIT ORGANIZATIONS BUT BY DESIGNING A NEW MODEL SPECIFIC TO THE TASKS AT HAND. WE APPROACH OUR
